

The AU ECW Compressor Licence

In simple terms this licence:

allows you to:

- * freely download and use AU_ECW_Compressor software, in whole or in part, for personal, company internal, or commercial purposes;
- * use AU_ECW_Compressor software in packages or distributions that you create.

and forbids you to:

- * redistribute any piece of AU Enterprises Limited or The Advisory Unit: Computers in Education-originated software without proper attribution;
- * use any marks owned by AU Enterprises Limited or The Advisory Unit: Computers in Education in any way that might state or imply that AU Enterprises Limited or The Advisory Unit: Computers in Education endorses your distribution;
- * use any marks owned by AU Enterprises Limited or The Advisory Unit: Computers in Education in any way that might state or imply that you created the AU Enterprises Limited or The Advisory Unit: Computers in Education software in question.

It requires you to:

- * include a copy of the Licence in any redistribution you may make that includes AU_ECW_Compressor software;
- * provide clear attribution to Limited for any distributions that include AU_ECW_Compressor software.
- * include the source of the AU_ECW_Compressor software, or of any modifications you may have made to it, in any redistribution you may assemble that includes it (except for those ECW libraries for which source code is not included in this software);

You do not have to:

- * submit changes that you make to the software back to AU Enterprises Limited or The Advisory Unit: Computers in Education (though such feedback is encouraged and welcome).

A few other clarifications include:

- * AU_ECW_Compressor is freely available without charge;
- * you may include AU_ECW_Compressor on a CD-ROM as long as you comply with the terms of the Licence;
- * you can give modified code away for free (but not sell it) under the terms of the AU_ECW_Compressor Licence, but you need to acknowledge the use of the AU_ECW_Compressor software;
- * the Licence is compatible with the GPL.

1. Definitions.

"Licence" shall mean the terms and conditions for use, reproduction, and distribution as defined by Sections 1 through 9 of this document.

"Licensor" shall mean the copyright owner or entity authorized by the copyright owner that is granting the Licence.

"Legal Entity" shall mean the union of the acting entity and all other entities that control, are controlled by, or are under common control with that entity. For the purposes of this definition, "control" means (i) the power, direct or indirect, to cause the direction or management of such entity, whether by contract or otherwise, or (ii) ownership of fifty percent (50%) or more of the outstanding shares, or (iii) beneficial ownership of such entity.

"You" (or "Your") shall mean an individual or Legal Entity exercising permissions granted by this Licence.
